### **COMMITTEE SPOTLIGHT**

Community Standards Committee

The Community Standards Committee is made up of representatives from the The Board of Directors, the Design Review Board, and The Covenants Committee. It is Chaired by At-Large Resident Kevin Schmidt. This mission driven group meets monthly, and is tasked with creating a "Community-Wide Standards" document that allow residents to have a clear idea on some of the easier design elements, such as pinestraw. While also adding clarification to some rules outlined in both the Covenants and Rules and Regulation documents. Below is the definition of "Community-Wide Standards" that is laid out in the Covenants.

"The standard of conduct, maintenance, or other activity generally prevailing within The Ponds, or the minimum standards established pursuant to the Design Guidelines, Governing Documents and Board Resolutions, whichever is the higher standard. Such standard shall be established initially by Declarant and may contain both objective and subjective elements. The Community-Wide Standards may evolve as development progresses."



# Takin' Care of Business Pool Rules

- POOL OPERATION HOURS ARE DAWN (7AM) UNTIL DUSK. VIOLATORS OF THE POOL HOURS WILL BE SUBJECT TO THE LOSS OF AMENITY ACCESS.
- CHILDREN UNDER OF THE AGE 14 MUST BE ACCOMPANIED BY AN ADULT(18) AT ALL TIMES WHILE USING THE POOL.
- GLASS IS NEVER ALLOWED IN THE POOL AREA.
- FOOD IS NOT ALLOWED IN THE POOL OR ON THE SIDE OF THE POOL. RESIDENTS ARE ALLOWED FOOD ON THE DECK AWAY FROM THE POOL. ALL TRASH MUST BE DEPOSED OF PROPERLY.
- APPROPRIATE SWIMMING ATTIRE IS REQUIRED WHILE IN THE POOL. STREET CLOTHES ARE NOT ALLOWED.
- RUNNING, PUSHING, FIGHTING, WRESTLING, DUNKING, HORSEPLAY, SPITTING AND STANDING OR SITTING ON ANOTHER'S SHOULDERS IS PROHIBITED, AS THIS ENDANGERS OTHER SWIMMERS.
- NO WHEELED VEHICLES ARE ALLOWED IN THE POOL AREA EXCEPT FOR STROLLERS AND WHEELCHAIRS.
- NO ALCOHOLIC BEVERAGES ARE PERMITTED IN THE POOL AREA. PERSONS UNDER THE INFLUENCE OF INTOXICANTS ARE NOT PERMITTED IN THE POOL AREA. SMOKING AND TOBACCO USE IS NOT PERMITTED.
- ANY INCIDENTS INVOLVING ACCIDENTAL MATTER ENTERING THE POOL MUST BE REPORTED TO MANAGEMENT IMMEDIATELY FOR PROPER TREATMENT. THIS INCLUDES SWIM DIAPER FAILURES ETC. ANYONE EXPERIENCING STOMACH ISSUES INCLUDING UPSET STOMACH, DIARRHEA OR VOMITING SHOULD NEVER USE THE POOL.
- ANY PERSON WITH A CUT OR OPEN WOUND MAY NOT USE THE POOL.
- DESTRUCTION OR IMPROPER USE OF AMENITIES INCLUDING VANDALISM AND UNAUTHORIZED USE WILL NOT BE TOLERATED.
- OWNERS ARE RESPONSIBLE FOR THE ACTIONS OF THEMSELVES, CHILDREN AND GUESTS AT ALL TIMES. AMENITY LOSS, FINES FOR DAMAGES AND POSSIBLE PROSECUTION WILL BE ENFORCED.
- RESIDENTS ARE PERMITTED TO BRING THEIR PERSONAL OUTDOOR CHAIRS INTO THE POOL AREA.
- NO DIVING IS PERMITTED.
- NO SKATEBOARDS, ROLLER BLADES OR SKATES SHALL BE USED IN AND AROUND THE POOL AREAS.
- FIVE (5) GUESTS PER HOUSEHOLD ONLY. RESIDENTS MUST ACCOMPANY GUESTS AT ALL TIMES.
